

LEASE

THE STATE OF SOUTH CAROLINA,
County of Greenville,

I, E. Guffilling, of Greenville, South Carolina, lessor,
in consideration of the rental hereinbefore mentioned, have granted, bargained and released and by these presents do grant, bargain, and lease unto,

H. S. Judy of Greenville, South Carolina, lessee,
for the following use, viz., Business,

The first floor of the two story brick building known as the
Hill and the tenth corner of Main Street North Street in Greenville, South
Carolina, to commence November 1st, 1945 and
to terminate October 31st, 1955.

and the said lessee
in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of \$2170.00 Dollars

payable monthly in fullments as
lessor shall demand.

The lessor hereby agrees to use the building just as it stands unless otherwise agreed upon in writing, and the lessee only require of the lessor the use of the premises for the business mentioned but no other. The lessor to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages from hawks should any occur. Use of the premises for any business other than herein called for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the lease then the whole of the unexpired time becomes immediately due and payable.

Outside signs to be erected shall may connect with the parties or any other outside part of the building must be consented to by the lessor before being erected.

Received of H. S. Judy a sum of \$2170.00 Dollars
for the use of the above described premises for the term
from November 1st, 1945 to October 31st, 1955 to
use as a Business for the sum of \$2170.00 Dollars on the 15th day
of each month during November 1st, 1945 to October 31st, 1955.
For Business \$2170.00 Dollars on the 15th day of each
month from November 1st, 1955 to October 31st, 1955.

To have and to hold the said premises unto the said lessor
executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the
party desiring to terminate it after the expiration of the term above mentioned give to the other party 3 months written notice previous
to the time of the desired termination, but the destruction of the premises by fire or making it unfit for occupancy or other casualty, or 12
months amount of rent, shall terminate this lease, if the lessor so desires. The lessee agree to make good all breakage of glass and all other injuries done to the
premises during the term, except such as are produced by natural decay and agree to make no repairs, improvements or alterations in the premises without the
written consent of the lessor nor sub-rent without the lessors written consent.

The lessee hereby acknowledges having a copy of this lease.
