

LEASE

THE STATE OF SOUTH CAROLINA,  
County of Greenville.

Dr. J. E. Hamilton of Greenville, South Carolina lessor,  
in consideration of the rental hereinafter mentioned, have granted, bargained and released and by these presents do grant, bargain, and lease unto  
W. S. Judy of Greenville, South Carolina lessee,

for the following use, viz: Hotel House  
The first floor of the two story brick building known as the  
Hotel on the north side of West North Street in Greenville, South  
Carolina for the term of ten years commencing November 1st, 1955 and  
terminating October 31st 1965

and the said lessee  
in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of Twenty One Dollars and  
Twenty Cents (\$21.00) Dollars.

payable in monthly installments as  
per schedule annexed hereto  
The lessee hereby agrees to take the building just as it stands unless otherwise agreed upon in writing, and the lessee only require of the lessor the use of the  
premises for the business mentioned but no other. The lessor to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the  
lessor not to pay any damages from leaks should any occur. Use of the premises for any business other than herein called for shall cancel this lease if the  
lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the lease then the whole of the unexpired time becomes immediately due  
and payable.

Outside signs to be erected that may connect with the gutter or any other outside part of the building must be consented to by the lessor before be-  
ing erected.

Twenty One Dollars and Twenty Cents (\$21.00) Dollars  
annually commencing on the 1st day of November 1955 and the  
1st day of each month from November 1st 1956 to  
October 31st 1957  
and twenty one Dollars (\$21.00) Dollars on the 1st day  
of each month from November 1st 1958 to October 31st 1959  
and twenty one Dollars (\$21.00) Dollars on the 1st day of each  
month from November 1st 1959 to October 31st 1965

To Have and to hold the said premises unto the said lessee W. S. Judy  
executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the  
party desiring to terminate it after the expiration of the term above mentioned give to the other party 30 months written notice previous  
to the time of the desired termination, but the destruction of the premises by fire or making it unfit for occupancy or other casualty, or 30  
months accrual of rent, shall terminate this lease, if the lessee so desires. The lessee agree to make good all breakage of glass and all other injuries done to the  
premises during the term, except such as are produced by natural decay and agree to make no repairs, improvements or alterations in the premises without the  
written consent of the lessor nor sub-rent without the lessor's written consent.

The lessee hereby acknowledges having a duplicate of this lease.
