The receipt whereof is hereby acknowledged, done, bargained, sold and delivered, and by these presents do Grant, Bargain, Sell and Release unto the said

A. L. H. G. & wife, the following described property:
All that certain piece parcel or lot of land situate, lying and being on the
city and County of Greenville, State of South Carolina, on the south side of East
McKee Ave. and abutting the following streets and bounds, to wit:

Beginning at corner and on the south side of East McKee Ave., corners of lots now or
formerly owned by J. A. Weston, a distance of 43.5 feet west of the intersection of
East McKee Ave. and Davis St. and running thence along line of Davis prop-
erty, 60 feet, more or less, to a stake, thence on a westerly direction along line
of Davis property and along property of J. A. Brock 48 feet, more or less, to
a stake, thence on a northwesterly direction with line of Brock property, 60
feet, more or less, to a stake on East McKee Ave. thence along south-
side of East McKee Ave. on an easterly direction 17.7 feet more or less to the beginning corner.
The foregoing came property conveyed to me by Andrew Young, Edmund White and Mary Bates, Trustees
the Gold Standard Lodge No. 5 by deed dated Aug 27, 1920, recorded in the R.M.C. Office for Greenville
County in R. M. C. Book 45 at page 575.

Also, All that certain lot of land situated on the eastern portion of the City of
Greenville, County of Greenville, and State of South Carolina, and being known and designated
as lot No. 2 and B according to a Plat of the estate of H. C. Elizabeth's Estate, made by P. E.
Talton September 22, 1921, and having the following streets and bounds and corners
and distances to wit. Beginning at my corner pipe on Moredeci St. and running
thence S. 70° 30' E. 48.5 feet to another pipe, thence N. 20° 12' E. 86 feet to fence post, thence
N. 70° 30' E. 48.5 feet to fence post on Moredeci St. thence along the western line
of said St. S. 20° 23' N. 86 feet to the beginning corner. This being the same prop-
erty conveyed to me by the Grant by deed dated Nov. 28, 1924, recorded in the R.M.C.
Office for Greenville County in Deed Book 605 at page 56.

Also, All that piece parcel or lot of land in Greenville Township, Greenville
County, State of South Carolina, and having the following streets and bounds, to wit:
Beginning *I* on corner on the east side of Bennett St., point corner of lot No. 3 and 4
and running thence along line of lot No. 4 and 6 S. 71° 20' E. 120 feet to a pin, thence N. 20° 14' E.
with line of lot no. 5 and 7, 60' feet to a pin, thence N. 71° 20' E. 120 feet to a pin on Bennett St.
thence with said Bennett St. S. 18° 30' E. 36' feet to the beginning corner. This being the same prop-
erty conveyed to me by William D. Austin by deed dated Jan. 5, 1926, recorded in the R.M.C. Office for
Greenville County in Deed Book 798 at page 279.

Also, All that certain lot, piece or parcel of land situated lying and being in the
State of South Carolina and County of Greenville, in the Second Ward of the City of Greenville, having
the following streets and bounds, to wit:

Beginning at a stake on the south east corner of Calhoun and Bennett Sts. and running thence along
the south side of East Erie St. S. 71° 20' E. 60 feet to a pin on the north west corner of lot no. 5,
thence with line of said lot S. 18° 30' E. 150 feet to a pin on the north east corner of the lot con-
veyed by Mr. Olive A. Peace to the Realty Corporation by deed recorded in the office of the R.M.C.
for Greenville County and State on Deed Book 28, at page 346; thence with line of said lot men-
tioned lot N. 71° 20' E. 60' feet to a pin on Bennett St. thence along the east side of Bennett St. N.
18° 30' E. 150' feet to the beginning corner. Being all but the south end of lot no. 3 of Section "G" on
Plan No. 1 of the Stone Land Company property filed in said office in Deed Book 16 at page 327.
This being the same property conveyed to me by H. C. Marshall by deed dated May 1, 1925
recorded in the R.M.C. Office for Greenville County.
