Jessie S. Bennett, her heirs and assigns,

all that certain piece, parcel and tract of land in Austin Township, County and State aforesaid, and having the following metes and bounds, bearings and distances, according to the plan of the same made by Dalton and Neve, Engineers in February 1927:

Beginning at said iron pin on side of a 15 foot road at H. O. Groce corner, a distance of 864 feet from the Laurens Road, and bearing thence N. 50° 30' W. 265 feet; thence N. 24° 30' W. 100 feet; thence N. 30° 30' W. 220 feet; thence N. 48° 30' W. 127 feet to beam; thence N. 35° 10' N. 308 feet; thence N. 32° 30' W. 420 feet to iron pin; thence N. 34° 10' E. 730.5 feet to iron pin, thence continuing N. 34° 10' E. 147 feet to an iron pin in center of the C. & St. L. Railroad; thence running the center of said Railroad as line S. 62° 10' E. 150 feet; thence S. 67° 30' E. 150 feet; thence S. 78° 30' E. 100 feet; thence S. 184° 20' E. 150 feet; thence continuing as the center of the said railroad as line S. 85° 40' E. 300 feet; thence S. 83° 45' E. 150 feet; thence S. 77° 30' E. 250 feet to point in center of the C. & St. L. Railroad, corner of property now or formerly owned by D. F. & F. L. Smith; thence running along the Smith line S. 16° 30' N. 20' 37 feet to a stake; on J. R. Pace line; thence along Pace line N. 64° 0' N. 420 feet to an iron pin on 15 foot road; thence running along side of said road N. 13° 35' E. 174 feet to the beginning.
