(the receipt whereof is hereby acknowledged) have Conveyed, Transferred, Sold and Delivered, and by these presents do Grant, Bargain, Sell and Release unto the said

H. H. Griffin; all that certain piece, parcel or tract of land, situate in the State and County aforesaid, about four miles southwest of the Greenville County Court house and being situate on the White Horse Road and having the following metes and bounds, to wit:

"Beginning at a rock, corner of the W. H. Griffin and Fleming lands and running thence N. 15° 15' 15" E. 359 feet to a rock; thence N. 15° E. 37' feet to a rock; thence N. 168° E. 919 feet to a rock; thence N. 72° 30' E. 83 feet to a rock; thence N. 76° 15' E. 144 feet to a rock; thence N. 81° 15' E. 785 feet to center of White Horse Road; thence S. 2° 16' 18.2 feet with said road to center of Gibbon Road; thence N. 86° 15' N. 18.2 feet to road in said road; thence S. 83° 30' N. 16.3 feet to center of said road; thence S. 48° 30' N. 2330 feet to dog wood and rock; thence S. 31° 30' E. 264 feet to neck of creek branch; thence S. 87° 30' N. 317 feet to rock; thence S. 43° 45' N. 422 feet to rock; thence S. 19° 30' E. 338 feet (crossing small branch) to rock; thence S. 40° E. 234 feet to rock; thence S. 11° 45' E. 840 feet to rock; thence N. 79° 30' N. 550 feet to rock; thence S. 8° 15' N. 565 feet to rock; thence S. 74° 30' E. 620 feet to poplar on branch; thence up said branch about 1400 feet to Dunk Dial corner; thence N. 88° 34' 1260 feet with Dunk Dial's northern line and extends 65 feet beyond Dunk Dial corner to corner of Indebent Quans line; thence with their line, N. 4° 15' E. 1270 feet to rock; thence N. 42° 05' E. 255 feet to center of farm road; thence with said road, N. 56° E. 671 feet; thence N. 64° E. 100 feet; thence S. 54° 45' E. 202 feet; thence S. 83° 15' E. 90 feet; thence S. 60° 30' E. 291 feet to center of Gibbon Road near the old home; thence with said road, N. 43° 3° E. 751 feet; thence N. 37° E. 384 feet; thence N. 45° E. 165 feet to point in center of said road; thence N. 86° 30' 103 feet to the beginning corner.
