All that certain place, parcel or lot of land in the County of Greenville, State of South Carolina, being known and designated as Lot No. 12 on plat of property of the Estate of T. Q. Donaldson made by C. M. Furman, Engineer, May, 1927, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book "I" at page 26, and having, according to said plat, the following notes and bounds, to-wit:-

Beginning at a point on the north side of Crescent Court, which point is 255 feet west of the northwest intersection of McDaniel Avenue and Crescent Court, and running thence along the joint line of Lots Nos. 11 and 12, N. 9-0 E. 225.8 feet to a point, joint rear corner of Lots Nos. 11 and 12; thence S. 68-35 W. 122 feet to an iron pin; thence S. 1-45 E. 263.3 feet to an iron pin in the north side of Crescent Court; thence along the north side of Crescent Court S. 81-0 E. 77 feet to the point of beginning.

Whereas, a plat of the property of the Estate of T. Q. Donaldson was made by C. M. Furman, Engineer, June, 1927, which plat is recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "G", at page 167, and
