Whereas, Carolina Public Service Company entered into a First Mortgage with AMerican Trust Company (now by change of name American Bank & Trust Company of -Richmond) and Clinton L. Williams, Trustees, dated April 1, 1982, and recorded in Spartanburg, S. C., R. M. C. office in Chattel Mortgage, Book 76, Page 477, and in Real Estate Mortgage Book 130, Page 107, and recorded in Charleston County, S. C. P. M. C. Whereas, Scutzern Ice Company is the successor in interest of Carolina Public Service Company under the said First Mortgage, having assumed the payment of the bonds secured by the same and standing in the place and stead of the said Carolina Public Service Company, and

Whereas, Section 2 of Article VIII of the aforesaid First Mortgage dated April 1. 1923, provides that the Trustee thereunder May resign and discharge itself from the trust thereby created by giving notice in writing to the Company thirty days before such regigna tion shall take effect, or such shorter notice as the company may accept as adequate, and in the event of the resignation of the Trustee, or should the said American Trust Company, its successor or successors in the trust, refuse, fail or in any way become incaracitated to execute the trust thereby created, then the Board of Directors of the Company small select a Trustee or Trustees in the place and stead of the then existing Trustee, and, upon the acceptance in writing of said trusts by such selected Trustee or Trustees, and delivery thereof to the President of the Company, the same shall be recorded in the same office in which the aforesaid First Mortgage is recorded, which acceptance and recordation shall have the effect of substituting the thus selected Trustee or Trustees in the place and stead of the retiring Trustee or Trustees with all the povers, rights and duties, therein conferred and imposed upon the American Trust Company (now by change of name American Bank & Trust Company of Richmond) as such Trustee; and all the estate, rights, powers and duties of the said Trustee shall be and become vested in such substituted successor or successors; and said Trustee so selected shall always be a well estabilished Trust Company in the State of South Carolina or in the State of Virginia, and

Whereas, the said American Bank & Trust Company of Richmond and its Receivers have resigned and discharged itself and themselves from the trust created under the aforesaid First Mortgage, dated April 1, 1922, and Indentures supplemental thereto, dated June 14, 1927 and February 15, 1928, respectively, by giving notice in writing to Southern Ice Company (successor in Interest to Carolina Public Service Company), as provided by said Section 2 of Article VIII of the aforesaid First Mortgage, and

Whereas, the said American Bank & Trust Company of Richmond is now in receivership, and is in consequence incapacitated to execute the trust created under the said First Mortgage and Indentures supplemental thereto, and
