Nalle, her heirs and assigns forever, All that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, near the Monaghan Mills, known as Lot No 7 and part of Lot No 8 on plat of Morgan Hill recorded in Plat Book A, page 70, and having the following metes and bounds: Beginning at a stake on North side of O'Neal Street 238 feet east of Brandon Road, and running thence S. 7 $\frac{1}{4}$ W. 262 feet to stake on line of Lot No 2; the same with line of lots Nos 2 and 9, 74 feet to stake, corner of lot conveyed by Amos M.
