Being the same lot of land deeded to Almon Pollard by W. D. Hamner by his deed dated Oct 20th, 1924, and recorded in office of R. M. C. for Greenville County in Vol. 96, page 132, and deeded to Plauters Savings Bank by E. Larnard, Master by deed dated March 16th, 1934, and recorded in office of R. M. C. for Greenville County in Vol. 173 page 207.

Clerk that other lot of land situate lying and being in State and County aforesaid, Chick Springs Township, Town of Greer, on the right of way of Southern R.R. and having the following metes and bounds to wit: beginning at point of Greer Boarded Warehouse lot and right of way of Southern R.R. and running thence with line of Greer Boarded Warehouse Co., 141.9 feet to future st.; thence with said street 11.78 30' E. fifty feet; thence with line of Plauters Savings Bank 161.9 feet to right of way of Southern R.R. thence with said right of way to beginning of corner fifty feet.
