All that certain piece, parcel or lot of land
 situate, lying, and being in the State of South Carolina,
 County of Greenville, and being known and designated
 as Lot 158 according to a map or plat of property
 of Overbrook Land Company as made September 14, 1933
 by Helen Jones, engineer, which map or plat is recorded
 in Plat Book E, at page 252 in the R.M.C. Office for
 Greenville County, South Carolina, reference to which is
 hereby made as a part of this description; said
 lot of land being described by metes and bounds
 as follows, to-wit:

Beginning at a stake on the Southern line of
 Walnut Street, as shown on said plat, said place
 of beginning being the northern corner of lot fifty-eight
 (58) as above on said plat and running thence
 south 9 deg. 57 min. West one hundred eighty-seven
 and seven-tenths (187.7) feet to a stake on the Northern
 line of Overbrook Road, thence along said Northern
 line of Overbrook road, North 89 deg. 57 min. East two hu-
 dred and ten (210) feet to a stake; thence North 27
 deg. 57 min. East, following the curve at the intersection
 of Overbrook Road and Spruce Street, forty-four and
 one tenth (44.1) feet to a stake on the Southwest line
 of Spruce Street, thence along said Southwest line of
 Spruce Street North 41 deg. 67 min. West thirty-seven and
 two tenths (37.2) feet to a stake, thence continuing
 along said Southwest line of Spruce Street North 341
 deg. 50 min. West ninety-two and seven tenths (92.7)
 feet to a stake, thence continuing along said Southwest
 line of Spruce Street North 46 deg. 38 min. West Forty-two
 and eight tenths (428) feet to a stake, thence continuing
 along said Southwest line of Spruce Street, North 67 deg.
 5 min. West thirty-three and nine-tenths (33.5) feet to a
 stake on the Southern line of Walnut Street; thence along
 said Southern line of Walnut Street North 87 deg. 4 min.
 West fifty (50) feet to the place of beginning.
