Chiles, his Heirs and assigns: All that certain tract of land, lying and being in Greenville County, State aforesaid, in Greenville Township, about 3 miles from the Greenville County Court House on the west side of the White Horse Road, containing fifteen (15) acres more or less and having the following lines and bounds to wit: Beginning at a stake in the center of the White Horse Road, corner of the land of or formerly of J. R. Young, running thence with his line S. 74-55 N. 9065 feet to a point in the road; thence S. 34-20 E. 852 feet to a point in line of land now or formerly of Cochran, thence with line of Cochran, N. 58-53 E. 9126 feet to a stake in center of White Horse Road; thence with center of said road N. 34-20 E. 584 feet to the point of the beginning.
