aforesaid, on the south side of Harvey Street, and being
dimension and description as Lot No. 14 as shown on
plat recorded in Plat Book "E" at page 314, and
containing according to said plat the following metes
and bounds, to wit:

Begins at an iron pin on the South side of
Harvey Street, joint corner of Lots Nos. 13 and 14,
thence thence with the joint line of said lots S. 6-28
E. 143.8 feet to an iron pin in Bull's Alley; thence
with Bull's Alley N. 87-48 W. 57 feet to an iron pin,
