TITLE TO REAL ESTATE

That lot or parcel of land being located on the Easley BFidge Road diagonally across the said road from property of the Piedmont Plush Mill, at intersection of an alley with the Easley Bridge Road, adjoining property of M. H. Kelley Sstate and to construct, maintain in and upon and use in and through said premises, in a proper manner, with necessary apparatus and appliances such as machinery, air vents, manholes, blowoff connections and any and every other necessary and proper attachment, pipe lines, for water and sewerage purposes through the premises above described, together with the right at all times to enter in and upon said premises for the purpose of inspecting and making necessary repairs and alterations of said line, together with the right to cut away and keep clear of said pipe lines all trees and other obstructions that may in any way endanger the proper operations of same. IT IS FURTHER AGREED AND UNDERSTOOD: That this casement is to be used only during the construction or repair of said pipe lines and with the exception of the right of the Grantee, its successors and assigns, agents, servous, and employees to inspect said pipe lines and to enter at any point and make repairs, the Grantee, its successors and assigns, agents, servous, and employees to inspect said pipe lines and to enter at any point and make repairs, the Grantee its successors and assigns, agents, servous, and this shall not apply to such part wherein the top of the pipe is less than eighteen (18) inches underground. The payment and privileges above specified are hereby accepted in full settlement of all claims and damages for said easement.
