TITLE TO REAL ESTATE.

the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said *M. J. Bouch*, all that certain piece, parcel, or lot of land in Greenville County, Greenville Township, State of South Carolina, on the north side of Lucille Avenue in the City of Greenville, being known and designated as lot #7 of Block 14 of the Chapin Springs Land Company property as shown on plat recorded in the R.M.C. office for Greenville County in Plat Book 8 at page 41, and having according to the said plat the following metes and bounds: Beginning at a corner of Lot #6 on Lucille Avenue and running thence with line of lot #6 N. 12 W. 120 ft. to joint corner of Lots #6 and #7, #17, and #18 thence with line of lot #17 N. 88 E. 50 ft. to joint corner of lots 7, 8, 16 & 17; thence with line of lot #8 S. 2 E. 120 ft. to Lucille Avenue; thence with Lucille Avenue S. 88 W. 50 ft. to beginning corner.
