TO ALL WHOM THESE PRESENTS SHALL COME:

I, E. INMAN, Master in and for the County aforesaid, SEND GREETINGS:

WHEREAS, *Wm. Link & Son*

on or about the *14th* day of *November* in the year of our Lord nineteen hundred and *thirty-five* exhibited *his* complaint in the Court of Common Pleas for the County aforesaid, against *Jennie V. Link, Thomas E. Link Jr. and James H. Link*

demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the *13th* day of *January*, 19*36* and such proceedings were had therein as resulted in a Decree

of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described be sold by E. INMAN, Master in and for the County aforesaid, on the terms and for the purposes mentioned in the said decree, as by reference thereto on file in said Court will appear; and the Master, after having duly advertised the said real estate

for sale by public outcry on the *3rd* day of *February* in the year of our Lord nineteen hundred and *thirty-six*, did then openly and publicly, according to the custom of auctions, sell and dispose of the same unto *Dorothy S. Link*

for the sum of *One Hundred (\$100.00)* Dollars, being at that price the highest bidder therefor.

NOW, THEREFORE, Know All Men by These Presents, That I, E. INMAN, Master in and for the County of Greenville aforesaid, in consideration of the sum of *One Hundred (\$100.00)* Dollars to me paid by the said *Dorothy S. Link*

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these Presents DO GRANT, bargain, sell and release unto the said *Dorothy S. Link*

"All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the Old Spartanburg Road about three and one half miles from the City of Greenville, containing one (1) acre, more or less, and having the following metes and bounds:

Commencing at a stake in the center of the location of the Old Spartanburg Road, corner of Amick property; thence along the center of Old Road N. 84-34 E. 208.7 feet to a stake in Old Road; thence along line of Jennie V. Dillard N. 0-03 E. 209 feet to an iron pin; thence continuing with same property S. 84-34 W. 208.7 feet to an iron pin in line of Amick property thence along line of said property S. 0-03 W. 209 feet to the point of beginning, Same containing one acre, more or less, Surveyed May, 1920, by R.
