in the City of Greenville, known as the Western half of Lot 22, Section B, plat of Stone Land Company recorded in R. M. C. O. for said County in Plat Book A, page 341, and having the following courses and distances:

Beginning at an iron pin on the North side of West Croft Street, corner of Lot No. 20 of Section "B", which pin is 108 feet 9 inches East of Robinson Street, and running thence with line of Lot 20 N. 1-41 E. 208 feet to center of alley, which was closed by agreement of the owners April 8th, 1924, see deed recorded in Book 100, page 204, thence with center of said alley S. 83-13 E. 54 feet 9/10 ^{inches} to corner of lot conveyed by Stella D.
