

TITLE TO REAL ESTATE

the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said A. B. Trammell, his heirs and assigns, all that piece, parcel or lot of land situate, lying and being in Austin Township, County and State aforesaid. More fully described as follows:

Beginning at an iron pin at Will Daylode's corner and running thence S. 82-30 W. 312 feet to an iron pin at the road near Bridges residence, thence N. 9 E. 165.5 feet to bend in road, thence N. 36 E. 180 feet to bend in said road, thence N. 14-45 E. 149 feet to iron pin in said road. Thence S. 82-30 E. 319 feet to iron pin, thence S. 16-45 W. 349 feet to the beginning corner and containing 3.22 acres more or less, and being a part of the same land conveyed to me by deed of J. S. Shackleton by deed dated Feb. 10, 1932 and recorded in R. M. C. office in Vol. 75 at page 121 and by W. M. Garrett to J. S. and J. O. Shackleton deed recorded in Vol. 9, page 349.
