All that certain piece, parcel or lot of land in County and State aforesaid, and being known and designated as part of Lot No. 5 on plat of what is known as the Westview property by S. A. Schulze and C. M. Surman Jr. Surveyors, recorded in the R. M. C. Office for said County in Plat Book 3, page 140, the portion covered by this conveyance having a frontage of 32 feet on the East side of King Street, a depth in parallel lines of 150 feet, and a width of 32 feet at the rear, and being the northern portion of said Lot No. 5.

Said Lot No. 5 was conveyed to American Building and Loan Association by American Land and Investment Company as Trustee by deed dated June 30, 1934 and recorded in Book 177, page 217.
