Whereas the said James H. Johnson, Sr. owned various parcels of real esta te, which now belong to the said James H. Johnson, Jr. and Elizabeth J. McClenaghan, who have agreed upon an equal division thereof, by exchanging deeds, now therefore,

Know all men by these presents, That I, James H. Johnson, Jr., in the State aforesaid, in onsideration of the sum of One (\$1) Dollar and a division of real estate of James H. Johnson, Sr., deceased, to me in hand paid at and before the sealing of these presents by Elizabeth J. McClenaghan, (the receipt whereof is herby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Elizabeth J. McClenaghan all my right, title and undivided one-half interest of, in and to the following parcels of real estate:

"All those pieces, parcels or lots of land situate, lying and being in the City of Greenville, S. C. on and near Oscar St. in said City and having the following metes and bounds, according to plat of same made by R. E. Dalton, Engineer, January, 1922:

Parcel 1.

BEGINNING at iron pin on North side of Oscar St., corner of property of Lewis and Jane King, and running thence along the north side of Oscar St., S. 53-57 E. 94.5 ft. to iron pin; thence along the line of William Milla n's property N. 40-42 E. 122.8 ft. to iron pin; thence N. 46-02 E. 125.7 ft. to fence post in rear corner of lots facing Washington St.; thence along rear line of lots facing Washington St. N. 48-17 W. 156.2 ft. to pipe; thence along line of W.
