Pauline Nesbitt all our and each of our right, title, interest, estate, claim and demand whatsoever, both at law and in equity, in and to all that certain lot, piece, or parcel of land situate, lying and being in the First Ward of the City of Greenville, in said county and state, having the following metes and bounds, to wit: beginning at the south-west corner of Rutherford and Echols Streets and running thence with Echols Street in a direction somewhat south of west 210 feet, more or less, to corner of W. A. Hudson lot: thence with the Hudson line in a direction somewhat east of south lodfeet, more or less, to corner of lot formerly belonging to the Protestant Episcopal Church (see deeds in Book "PPP" at pages 530 and 539); thence with line of church lot in a direction somewhat north of east 1802 feet, more or less, to Rutherford Street; thence with Kutherford Street almost north 100 feet, more or less, to the beginning corner, being known and designated as Lot 10 in Block 1, page 20, on City Block Book, and being the same conveyed by Kate B.
