

CANCELLATION OF LEASE AGREEMENT

STATE OF SOUTH CAROLINA)

WHEREAS, by lease dated the 16th. day of October 1936, and recorded in the office of the Recorder of Deeds of Greenville County, State of South Carolina, in Book 188, page 337, H. S. SELLERS leased to the GULF OIL CORPORATION certain premises situate in the City of Greenville, County of Greenville, State of South Carolina; and,
