Chambers in and to the said above described property by virtue of a certain unrecorded contract of sale entered into on February 3, 1939, by Pilot Life Insurance Company and L. R. Chambers, all interest of said L. R. Chambers under said contract of sale having been heretofore transferred and assigned unto the said Catherine Brockman (single), grantee herein.
