

## TITLE TO REAL ESTATE

State of South Carolina,  
County of Greenville.

Know all men by these presents: That C. J. McKinney of said County and State, for and in consideration of the premises, and of the sum of One and no/100 Dollars, to me in hand paid by Conyers and Gower, Inc., the receipt whereof is hereby acknowledged, do hereby grant unto the said Conyers & Gower, Inc., its successors, and assigns, the right, privileges and easement to go in and upon that tract of land, situated in Butler Township, in said County and State, bounded by lands of: Laurens Road on the North, West View Ave., on the East, Service Lane on the South and on the West by Simons, Burton, Lloyd and Johnson. Said property is located on the south side of the Laurens Road and approximately three miles from the Greenville, S. C., County Court House.

To Construct and maintain in, upon and through said premises, in a proper manner, a pipe line, for the purpose of conveying water through the premises above described, together with the right at all times to enter upon said premises for the purpose of inspecting said line and making necessary repairs and alterations thereon, together with the right to keep clear of said pipe line obstructions that may in any way endanger the proper operations of same.

It is understood and agreed that the right of way to be used under this contract is to be along the south side of the present side walk on the Laurens Road for a distance of 100 feet in length, more or less.

It is further understood that the owner is to have the same privileges and rights to use this right of way strip of land as it had prior to this agreement, provided, such use thereof will not interfere with the proper operation and maintenance of this line. Said pipe line is to be laid within two feet of the present sidewalk.

The payment above specified covers compensation for the easement or right of way.

This right of way is given subject to the right of way heretofore executed across the above described property to the South Carolina State Highway Department.
