WHEREAS, Gladys Moon

on or about the 9th day of May in the year of
our Lord nineteen hundred and forty-one exhibited her complaint in the Court of
Common Pleas, for the County aforesaid, against Dorothy Frances Moon Grice, et al.

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 28th
day of October, 1941, and such proceedings were had therein as resulted in a Decree

of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN, Master in and for
the County aforesaid, to Harry R. Stephenson,

for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgement Roll No. E-8918)

NOW, THEREFORE, Know All Men by These Presents, That I, E. INMAN, Master in and for the County of Greenville aforesaid, by virtue of the aforesaid
decree, and upon receipt of \$3,000.00.

HAVE GRANTED, conveyed and released, and by these Presents, DO GRANT, convey, and release unto the said Harry R. Stephenson

"All that certain piece, parcel or lot of land in Chick Springs Township,
Greenville County, State of South Carolina on Paris Mountain and being known and designated
as Lot No. 65 on plat of property of Paris Mountain Land Company, which is recorded in R.M.C.
Office for Greenville County, in Deed Book DDD, page 902, and having the following metes and
bounds, to-wit: Beginning at a stake on the mountain road near Markley Terrace, and running
thence with said road in a Northwesterly direction about 120 feet to a stake at corner of Lot
No. 64; thence along line of said lot, S. 62 1/2 W. 280 feet to corner of Lot 63; thence along
line of said lot, S. 20 1/2 E. 120 feet to line of Lot 66; thence with line of said lot 66, N.
62 1/2 E. 300 feet to the beginning corner.

Also, all that certain piece, parcel or lot of land situate, lying and being
in Paris Mountain Township, County and State aforesaid, and having the following metes and
bounds, to-wit: Beginning at the corner of lot formerly sold Egbert Carpenter now Bub Moon
and running thence with Markley Terrace 145 feet; thence with Trowbridge Avenue in a westerly
direction 150 feet; thence S. 20 1/4 E. 125 feet; thence with line of Carpenter or Moon, N. 62 1/2 E.
280 feet to the beginning corner, and being Lot 64, Section A, Paris Mountain.

Also, all that certain piece, parcel or lot of land lying and being situate in
the State and County aforesaid, Paris Mountain Township on the east side of Thompson Ave. and
being known and designated as Lots 68a, 68, 69 and 70 on the latter of which is located a two-
story frame dwelling, in Section A of Paris Mountain Property."
