I, E. INMAN, Master in and for the County aforesaid, SEND GREETINGS:
WHEREAS, J. R. Robinson, et al.

on or about the X day of September in the year of
our Lord nineteen hundred and forty-one exhibited their complaint in the Court of
Common Pleas, for the County aforesaid, against Roxie Robinson, J. C. Southerlin, and Jack Mooney

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 21st
day of October, 1941, and such proceedings were had therein as resulted in a Decree

of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN, Master in and for
the County aforesaid, to M. E. Robinson

for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgement Roll No. E-8903)

NOW, THEREFORE, Know All Men by These Presents, That I, E. INMAN, Master in and for the County of Greenville aforesaid, by virtue of the aforesaid
decree, and upon receipt of \$150.00

HAVE GRANTED, conveyed and released, and by these Presents, DO GRANT, convey, and release unto the said M. E. Robinson

"All that certain tract of land in Saluda Township, County of Greenville, State of South Carolina, and containing 5.8 acres, more or less, and known and designated as Tract No. 1, of the E. M. Robinson property, as shown on a subdivision and plat made by Dalton & Neves in September, 1941, and having the following metes and bounds and course and distances, as shown by said plat, to-wit:

Beginning at a point in or near the center of the North River Road, at northwest corner of Tract No. 3 on said plat, and running thence N. 23-12 W. 548 feet to a point in line of the Woodrow Robinson land; thence along the Robinson line S. 87-0 E. 928 feet to a point in or near the center of the North River Road; thence S. 27-0 W. 157 feet to a point in or near center of said road and a junction of another public road; thence S. 35-45 W. 118 feet to a point in or near center of said road; thence S. 67-20 W. 92 feet to joint corner of Tracts 4 and 3; thence along the line of Tract No. 3, S. 67-20 W. 495 feet to the beginning corner. This tract is bounded on the West by lands of M. E. Robinson, on the North and East by lands of Woodrow Robinson and on the South by the J. C. Southerlin land and Tracts 4 and 3 of the E. M. Robinson estate. The plat above referred to is of record in the R. M. C. Office for Greenville County in Plat Book "L", page 117."
The above land is located in Slater-Marietta School District 12-B.
