to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto T. B. Reeves

All that certain piece, parcel or lot of land situate, lying and being in Gantt Township, State and County aforesaid, and containing 8.95 acres, more or less, according to a survey made by W. J. Riddle, May 19, 1942, and being more particularly described as follows:

Beginning at a stone, corner of property of T. B. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinabove named, and his heirs and assigns forever.

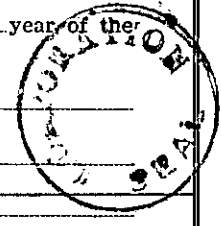
