Sudduth property prepared by W. P. Morrow, Surveyor, dated September, 1942, and having the following courses and distances, to-wit: Beginning on a stone on line of Fowler land and on the southwestern corner of the tract herein conveyed, and runs thence with line of Fowler land N. 4.30 E. 12.75 chains to a stake, corner of tract No. 4; thence with the line of tract No. 4 S. 89 E. 15.00 chains, crossing the Greer-Highland road, to a stake on branch; thence down the meanders of said branch as the line S. 7 1/2 W. 2.25 chains, S. 48 W. 1.00 chains, S. 52 E. 1.18 chains, S. 16 1/2 W. 1.65 chains, S. 18 1/2 E. 2.16 chains, S. 6 E. 1.65 chains, S. 21 1/2 E. 1.40 chains, and S. 22 1/2 W. .65 chains to a stake (E.
