All my right, title and interest, being a one-half undivided interest in and to all that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, on the Western side of Laurens Road, near the City of Greenville, and having the following metes and bounds, according to survey of the property of H. C. Harvley, as revised by R. E. Dalton in April 1943:

Beginning at a point in the center of Laurens Road, at center of the intersection of a County Road, and running thence with said County Road, S. 37-15 W. 199 feet to a stake; thence continuing with said Road, S. 58-24 W. 100 feet to pipe in center of said Road, in line of Hellams property; thence with line of Hellams property, N. 76-50 E. 331.5 feet to drill hole in center of Laurens Road, also marked by a pipe on the western edge of the pavement; thence with center of Laurens Road, N. 40-32 W. 178.6 feet to the beginning corner, containing one-half acre, more or less.
