Now therefore, I, W. R. Hale, owner of the said eighteen acres of land, in obedience to the expressed wish of my deceased wife, and for the better security and protection of my grandchildren, do hereby declare that this land shall be held by me, my heirs and assigns, in trust for my grandchildren according to the terms of a deed of trust already executed, dated Sept. 30, 1927, and filed same day in the office of R. C. for said Greenville County; and that I shall be charged with all the duties and responsibilities, and vested with all the powers & privileges as set forth at length in said Declaration of Trust.

The said land is included in acreage I bought from C. R. McJunkin by deed dated Nov. 18, 1905, and filed in Vol. RRR at page 280, 18 acres of which I afterward deeded to my wife by deed dated Aug. 19, 1922, and filed in Book 97, at page 171, where metes and bounds are set forth.
