Ansel M. Center and his heirs and assigns forever:

All that piece, parcel or lot of land in Glassy Mountain Township, Greenville County, State of South Carolina.
in Ebenezer School District No. 13-E, consisting of two tracts, bounded on the North by lands of
W. P. Center Estate; on the East by lands of W. P. Center Estate, Tessie Douglas and Effie Morrow;
on the South by lands of Tessie Douglas and Effie Morrow; and on the West by lands of Fate Dill
and Furman Ballew, containing in the aggregate Ninety-nine (99) acres, more or less, and having
the following courses and distances:

Tract No. 1: Beginning at a white oak near a small branch (old John Dill corner), and runs thence
N. 59 $\frac{1}{2}$ E. 30.00 chs. to a stone; thence N. 10 W. 5.50 chs. to a stone; thence W. 25.10 chs. to a
Spanish Oak (down); thence N. 36 W. 9.50 chs. to a stake; thence S. 50 $\frac{1}{2}$ W. 4.55 chs. to a stake;
thence S. 32 $\frac{1}{2}$ W. 4.12 chs. to a stake; thence S. 16 W. 5.80 chs. to a stake; thence S. 31 E. 55.00
chs. to a stake; thence S. 4 W. 8.17 chs. to a black oak; thence S. 34 E. 3.55 chs. to a red oak;
thence S. 81 E. 8.30 chs. to the beginning corner, this tract containing 59 acres, more or less.

Tract No. 2: Beginning on a red oak corner (old John Dill corner near Mill Road), and runs thence
in a west course to a rock near a branch; thence up the branch to the head of same; thence up the
hollow to a red oak corner near the top of Tillet's mountain; thence up the mountain to a chestnut
oak corner; thence N. 20 E. 22 chs. to a stone; thence running in an eastward course to Mill Road;
thence with the Mill Road to the beginning corner, this tract containing Forty (40) acres, more or
less.
