Pauline Nesbitt (incher individual capacity and not as trustee) and Clara Nesbitt all my right, title, interest, estate, claim and demand whatsoever, both at law and in equity, in and to all that certain lot, piece or parcel of land situate, lying and being in said state and county, in the City of Greenville, on the southwest corner of Rutherford and Echols Streets, known and designated as Lot 10 in Block 1 on page 20 of the City Block Book and being the same lot conveyed by Kate B. Simpson to Mrs. Carrie H. Nesbitt by deed dated November 20, 1912, and recorded in the office of the Register of Mesne Conveyances for said county in Book 21, page 496; and in and to all other real estate, if any, and personal property belonging to the estate of the said Carrie H. Nesbitt, who died intestate on October 26th, 1937, seized and possessed of the land hereinabove described, which, with her other property, descended by operation of the statute of distributions to her four children; C. Pauline Nesbitt, James N. Nesbitt, Clara Nesbitt and Mills Her three children last above named conveyed said lot of land to said C. Pauline Nesbitt, upon certain trusts, by deed dated February 3, 1939, and recorded in said office in Book 209, page 272. The said Mills M. Nesbitt died on July 12, 1941, leaving of full force his will dated March 2, 1937, admitted to probate on August 27, 1941, by the Probate Court for said county, and now on file in the office of said Court in Apartment 140, File 5, and recorded in will Book "T", page 223, by which will he devised and bequeathed all his property, including his undivided interest in said premises, to his wife, the grantor herein.

Pauline Nesbitt, as trustee under the trust deed above mentioned, or her successors to pay over and distribute to herself, individually, and to the said Clara Nesbitt my share of the proceeds of said premises when sold.
