comprising 64.02 acres, more or less, described as follows:

Commencing at a stone joint corners Tracts Nos. 1, 2, and 3, and running thence S. 29-10 E. 1127 feet to a pine; thence S. 87-30 E. 2390 feet to a pine at or near road; thence N. 2-55 E. 960 feet to a pine, joint corners Tracts Nos. 2 and 3; thence N. 87-30 E. along line of tract No. 2, 2988 feet to the beginning corner, being Tract No. 3, of the lands of Mrs. F. E. McWhite, deceased, as per plat thereof prepared by R. E. Dalton, Engineer, in July 1916.

Excepting, however, 4.46 acres conveyed by Ellen McWhite Johnson, Ethel McWhite Ray, Annie Bell McWhite Tripp, as trustees for W. B. McWhite, and as trustees for themselves and as trustees for each other, and W. B. McWhite, to Mary Hollingsworth on the 8th day of January, 1927, recorded in Book 112, page 314, in the R. M. C. Office for Greenville County, S. C.

The above tract of land was conveyed to me by Ellen McWhite Johnson, Ethel McWhite Ray, Annie Belle McWhite Tripp, as trustees for W. B. McWhite, and as trustees for themselves and as trustees for each other, and W. B. McWhite, on the ___ day of October, 1931, deed recorded in RMC Office for Greenville County, S. C. in Book 163, page 91.

ALSO: Beginning in a road, known as Springfield road corner of Blassingame tract, and running thence with the road N. 25 E. 200 feet, N. 27-15 E. 400 feet, N. 43 E. 300 feet, N. 27-30 E. 200 feet, N. 21-20 E. 300.7 feet to a corner in said road; thence N. 86-53 W. 625 feet to McWhite's line; thence S. 3-10 W. 1250 feet to my corner; thence S. 87-40 E. 21 feet to the beginning corner, and containing 9.38 acres, more or less.
