All that piece, parcel or lot of land in Butler \_\_\_\_\_ Township, Greenville County, State of South Carolina.

which consists of one half interest in eighty one and (81 77/100) seventy seven one hundredths acres more or less, lying on the waters of Enoree River, and bounded by the following lines:

Beginning at a stone, corner Est. J. W. Baker, Ebenezer Church, and Ernest J. DeCamps, and runs thence S. 86° 45' E. 3000 feet to the shore line of a proposed dam or lake, thence following the said shore line to and beyond Terrapin Shoals dam by the following courses and distances. N. 42° 50' W. 202 ft. N. 44° 43' W. 59 ft. N. 42° 13' W. 142 ft. N. 43° 31' W. 268 ft. N. 66° 11' W. 140 ft. N. 27° 26' W. 236 ft. N. 12° 40' W. 248 ft. N. 8° 23' W. 155 ft. N. 11° 29' W. 156 ft. N. 42° 34' W. 171 ft. N. 60° 58' W. 100 ft. N. 39° 49' W. 192 ft. N. 6° 46' W. 154 ft. N. 34° 13' W. 159 ft. N. 71° 59' W. 225 ft. N. 68° 25' W. 421 ft. S. 58° 11' W. 121 ft. S. 42° 10' W. 117 ft. S. 65° 40' W. 393 ft. and S. 39° 00' W. 413 ft. to a birch at the said shore line thence leaving the river S. 5° 25' W. 658 ft. to the beginning, and also permission and license, revocable by thirty days written notice, to cultivate and pasture the land lying between the above level lines, and the river.

The Grantees by the acceptance of this deed covenants and agrees, that they will indemnify and save harmless the grantor from all claims for damages to the land hereby conveyed on account of the erection of a dam or dams which may back water to the same elevation as the present surface water at the dam of the Terrapin Shoals development, or which may cause flood water beyond said level lines; that this shall be a covenant running with the land, binding upon the grantee, his heirs, executors and assigns.
