WHEREAS, Thomas B. Kehoe, Jr. and William P. Donnelly, Jr.,
both of Greenville, S. C.

did on the 21st day of June, 1946, file with the Secretary of State a written Declaration signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed Corporation is CAROLINA CRAFTMASTER

THIRD: That the principal place of business is Greenville, S. C.

FOURTH: That the general nature of the business which it is proposed to do is the manufacture, wholesale, jobbing and retail of leather goods and allied lines.

FIFTH: That the amount of the capital stock is \$1,000.00 Common; \$1,250.00 Preferred Stock. Dollars,

payable \$675.00 Common and \$500.00 Preferred immediately, remainder upon issue.

SIXTH: That the number of shares into which the capital stock is divided is 1,000 Common; 100 Preferred Dollars.
of the par value of \$1.00 and \$12.50, respectively.

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 20th day of June, 1946 at which a majority of all stock in value being present in person or by proxy the following were elected directors:

John M. Schofield, J. A. Putnam, and Sidney Smith

EIGHTH: That subsequently there was elected as President Thomas B. Kehoe, Jr.
as Vice-President, William P. Donnelly, Jr.; as Secretary, John M. Schofield
as Treasurer, John M. Schofield,

NINTH: That all requirements of Article 2, Chapter 153 Code of Laws of South Carolina, 1932, and all amendments thereto, have been duly and fully complied with, 50 per cent, of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in.....

NOW, Therefore, I, W. P.
