All that certain lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 22 on Plat of Property of H. G. Stevens made by W. J. Riddle, Surveyor, April 1941, and recorded in the R. M. C. Office for Greenville County in Plat Book M, page 9, and having the following metes and bounds according to said plat:

BEGINNING at a stake on Paris View Drive at corner of Lot No. 23, and running thence with Paris View Drive N. 35 E. 70 feet to stake at corner of Lot No. 21; thence with line of Lot No. 21, N. 55 W. 200 feet to stake in line of Lot No. 31; thence with rear line of Lots Nos. 31 and 30, S. 35 W. 70 feet to stake at corner of Lot No. 23; and thence with line of Lot No. 23, S. 55 E. 200 feet to the beginning corner, being a portion of the tract conveyed to Cherry Investment Company by Harry G.
