

exclusively with their up bringing, it being agreed that Atriel W. Cooper, the father of said children may see any of or all of said children at such times as may be convenient to Inez Hinton Cooper; the arrangements for said meetings to be made whenever practicable in advance; and it is further stipulated and agreed that Atriel W. Cooper shall pay to Inez Hinton Cooper for the support and maintainance of Inez Hinton Cooper and the four children hereinabove referred to, the sum of One Hundred Dollars (\$100.00) a month as long as the bonds of matrimony between the parties hereto shall remain unsevered, which said sum shall be payable at the rate of Fifty Dollars (\$50.00) on the 1st and 15th day of each month beginning with the date of these presents.

(8) It is hereby mutually covenanted and agreed that all of the covenants, stipulations, promises, agreements, assignments, conveyances and provisions in this instrument shall apply to and be obligatory upon the heirs, executors, administrators, personal representatives or assigns of the parties hereto or either of them.

(9) The parties here to covenant and agree that neither will undertake to visit the other nor in any way, either directly or indirectly interfere with what the other is doing, said parties as to each other to conduct himself and herself as though there had been no intermarriage between them.

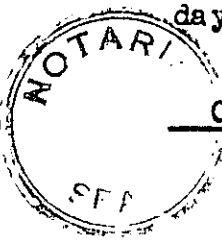
