NOW, THEREFORE, KNOWN ALL MEN BY THESE PRESENTS, That Bob Jones College, a corporation organized and existing under and by virtue of the laws of the State of South Carolina, and having its principal place of business at Greenville in the State of South Carolina, for and in consideration of the sum of One Dollar to it in hand duly paid at and before the sealing and delivery of these presents by Bob Jones College, a corporation organized and existing under and by virtue of the laws of the State of Tennessee, and having its principal place of business in Cleveland, Tennessee (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Bob Jones College, a corporation organized and existing under and by virtue of the laws of the State of Tennessee, and having its principal place of business in Cleveland, Tennessee, the following described property;

TRACT No. 1: All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, on the Southeastern side of U. S. Highway No. 29, being shown as tract No. 7 and the Western half of Tract No. 8 on plat pf property of A. B. Green, made by Dalton & Neves, July 1937, recorded in Plat Book D, in R. M. C. Office for said County and State, at pages 296-297, and more particularly described by metes and bounds in deed from Wavard W.
