NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, That I, George W. Brown, for and in consideration of the sum of One Thousand Five Hundred and no/100 (\$1,500.00) Dollars to me in hand paid by Greenville Bargain House, receipt whereof is hereby acknowledged, do hereby Grant, bargain and sell unto the said Greenville Bargain House, its successors and assigns, the right, privilege and easement to tie onto and to use the eastern wall of my building, located on the Northern, side of South Main Street, in the City of Greenville, Greenville County, South Carolina, more fully described in the deed of National Bond Holders Corporation to George W. Brown, dated December 30, 1936, and recorded in Book of Deeds 186, at Page 422, and to use my said Eastern Wall as the Western Wall for any building constructed on its said property by the Greenville Bargain House. The said easement shall constitute an easement appurtenant to the Land owned by said Greenville Bargain House, and shall pass with the Title thereof to the successive owners.
