to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto William T. Bishop, his heirs and

assigns:

All that certain piece, parcel or lot of land situate, lying and being on the East side of the Old White Horse Road, Greenville County, South Carolina, about two miles from the City Limits of the City of Greenville, being known and designated as Lot No. 2 of Central Realty Corporation property according to a plat of said property recorded in the R. M. C. Office for said Greenville County in Plat Book B, page 82, and having the following metes and bounds, to-wit:

Beginning at a point on the East side of said Old White Horse Road which is the joint corner of lots Nos. 1 and 2 according to said plat, which said point is 61 feet from the intersection of the Oil Mill Road and the Old White Horse Road, and running thence along the said Old White Horse Road, N. 0-57 E. 53 feet to a stake at the joint corner of lots Nos. 2 and 3; thence along the joint line of said lots Nos. 2 and 3, N. 85-48 E. 100 feet to a stake at the joint rear corner of lots Nos. 2 and 3; thence S. 1-32 W. 53 feet to a stake at the joint rear corner of lots Nos. 1 and 2; thence along the joint line of said lots Nos. 1 and 2, S. 85-48 W. 99.5 feet to the point of beginning, stake at the joint corner of lots Nos. 1 and 2 on the East side of Old White Horse Road.
