to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto John C. Amick, Jr., his heirs

and assigns:

All that certain lot of land situate, lying and being on the East side of the Old White Horse Road, Greenville County, South Carolina, about two miles from the City Limits of the City of Greenville, being known and designated as Lot No. 3 of Central Realty Corporation property according to plat of said property recorded in the R. M. C. Office for said Greenville County in Plat Book B, page 82, and having the following metes and bounds, to-wit:
