BEGINNING at an iron pin on the South side of Alaska Avenue which iron pin in 150 feet East of the Southeast intersection of Alaska Avenue and Neely Drive (which point is taken by projecting the lines of the two streets since the intersection is a curve instead of a corner), joint corner of Lots #8 and 9; thence along the joint line of said lots S. 36-17 E., 150 feet to an iron pin, rear joint corner of said lots; thence N. 53-43 E., 50 feet to an iron pin, rear joint corner of Lots #7 and 8; thence along the joint line of said lots N. 36-17 W., 150 feet to an iron pin in the line of Alaska Avenue; thence along the South side of Alaska Avenue S. 53-43 W., 50 feet to an iron pin, the point of beginning.
