assigns:

All that piece, parcel or lot of land situate, lying and being on the northwestern side of Graceland Street, near the City of Greenville, County of Greenville, State of South Carolina, shown as Lot No. 18 on a plat made October 1924, recorded in the R. M. C. Office for Greenville County in Plat Book G, page 14, and having according to said plat and to plat made by Pickell & Pickell, September 18, 1946, the following metes and bounds, to-wit:

Beginning at a stake on the northwestern side of Graceland Street, 150 feet from the intersection of Graceland Street and Pendleton Road, and running thence N. 58-05 W. 152.7 feet to a stake; thence N. 30-00 E. 50.1 feet to a stake at the rear corner of Lot No. 19; thence along the line of that lot, S. 58-05 E. 154.5 feet to a stake on the northwestern side of Graceland Street; thence along the said Graceland Street, S. 31-55 W. 50 feet to a stake at the corner of lot No. 3, the point of beginning.
