to it in hand duly paid at and before the sealing and delivery of these presents by the grantee..... hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Elsie Hill Smith, his heirs and

assigns:

All that piece, parcel, or lot of land situate, lying and being on the Western side of Clairemont Drive, near the City of Greenville, County of Greenville, State of South Carolina, shown as Lot No. 9 on a plat of property of Central Realty Corporation known as Shrinewood, dated July 1946, made by W. J. Riddle, recorded in the R. M. C. Office for said Greenville County in Plat Book B, page 86, and being more fully described as follows according to said plat, and according to plat made by Pickell & Pickell, September 25, 1946:
