All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

in that section known as Sans Souci, about two miles north of the City of Greenville, between Belmont Avenue and Newland Avenue, on Paris Mountain Avenue, said lot having the following lines, courses and distances:-

BEGINNING at an iron pin on the northern edge of a five (5) foot sidewalk running along Paris Mountain Avenue, said pin being the joint front corner of lots numbered forty-four (44) and forty-five (45); thence along the eastern line of lot forty-four (44), N. 5-50 W., one hundred and two feet (102) feet, to an iron pin, joint rear corner of said lots forty-four (44) and forty-five; thence along the southern line of lot forty-three (43), sixty-five (65) feet, to an iron pin, joint rear corner of lots forty-five (45) and forty-six (46); thence along the western line of lot forty-six (46), S. 5-50 E., ninety-eight (98) feet, to an iron pin on the northern side of said sidewalk running along Paris Mountain Avenue, said pin being the joint front corner of lots forty-five (45) and forty-six (46); thence along the northern edge of said sidewalk, S. 84-28 W., sixty-five (65) feet, to an iron pin, the beginning corner, said lot being known and designated as lot numbered forty-five (45) on plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "O" at Page 45, which plat is hereby referred to and made a part hereof.

Said property is in a restricted district, and is sold subject to the following restrictions, which constitute a part of the consideration thereof, and shall be effective for a period of twenty-five (25) years from the date hereof:-

- (1) Said property is to be used for residential purposes only.
- (2) No residence is to be built thereon at a cost of less than three thousand dollars (\$3,000.00).
- (3) No house is to be built thereon nearer the northern edge of said sidewalk running along Paris Mountain Avenue than twenty (20) feet.
- (4) Said property is not to be sold to any person of African descent.

Grantee assumes and agrees to pay that mortgage given by John E. Sloan and Corrine M. Sloan to O. Y. Brownlee, for \$334.99 dated December 21, 1946, to be recorded herewith.
