WHEREAS, on July 29, 1942, E. T. Hudson executed his power of attorney to said Frank T. Barnett and Joe F. Barnett authorizing them to execute and deliver all necessary papers in his name and on his behalf, as recorded in the RMC office for Greenville County in Vol. 246 at page 305, and,

by us simply as "Attorneys-in-fact" and not in the name of and on behalf of
the principals under the power of attorney, and,

WHEREAS, said W. W. Smith is now desirous of perfecting his title, now therefore,

KNOW ALL MEN BY THESE PRESENTS, That we, Frank T. Barnett and Joe F. Barnett, individually, and Pinkney G. Barnett, John S. Barnett, Jerry Barnett, Bettie Barnett Freeman, Maude Barnett McCombs, Lillie J. Barnett Kay, Mittie Barnett Johnson and E. T. Hudson, by Frank T. Barnett and Joe F. Barnett

All that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid, Greenville Township, about two miles from Greenville County Courthouse, on the south side of Waco Street, (formerly Hudson Street), being known and designated as Lot No. 13 of the property of J. R. West as shown on plat thereof recorded in the R.M.C. office in plat book "C" at page 190, and having the following metes and bounds, to-wit:
