to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Robert H. Bell, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being on the northeastern side of Griffin Drive, near the City of Greenville County of Greenville, State of South Carolina, known and designated as lot No. 38 of College Heights, according to a plat of said property made by Dalton & Neves, August 1946, recorded in the R.M.C. Office for said Greenville County in Plat Book P, page 75, and having according to said plat the following metes and bounds, to wit: BEGINNING at a stake 75 feet from the northeastern intersection of Princeton Avenue with Griffin Drive, at the corner of lot No. 39, and running thence along the line of said lot N. 56-50 E. 150 feet to a stake at the rear corner of lot No. 39; thence N. 33-10 W. 75 feet to a stake at the rear corner of lots Nos. 37 and 8; thence along the line of lots Nos. 8 and 7, S. 56-50 W. 150 feet to a stake on the said Griffin Drive; thence along Griffin Drive, S. 33-10 E. 75 feet to the point of beginning.
