All that piece, parcel or lot of land in Highland Township, Greenville County, State of South Carolina
containing Fifteen and Fifteen one hundredth acres more or less, lying on the east side of the
Gap Creek road and having the following courses and distances: Beginning on a point in said
road; thence N. 81 E. 2.30 ch. to a stake in the branch the W. M. Sudduth corner, thence down the
Branch the W. M. Sudduth corner, thence down the branch as the line S. 2 E. 1-70 ch. to a bend,
thence S. 41 E. 185 to a bend, thence S. 1/2 W. 2.60 to a point in Wild Cat creek; thence N. 58 E.
1.35 to a point in the branch, thence up the branch as the line S. 14-30 E. 3.85 to a bend; thence
S. 14 E. 2.70 ch. to a bend, thence S. 5 E. 2.20 to a bend, thence S. 19 W. 3.35 ch. to a bend,

bend, thence S. 32 E. 3.55 to a black gum, thence S. 28 E. 4.00 ch. to a bend, thence S. 8 E.
2.70 to a bend, thence S. 18 W. 2.18 to a stone, thence S. 64 W. 75 links to a bend, thence S.
8 1/2 W. 1.42 to a stake in ditch thence up the water way S. 76 1/2 W. 7.00 ch. to a point in Gap creek
road, thence up the road as the line N. 2 E. 8.18 ch. to a bend, thence N. 1/2 E. 21.61 ch. to a
bend, thence N. 23 1/2 W. 3.22 ch. to a point on the Bridge Wild Cat Creek, thence N. 28 1/2 W. 5.86
ch. to a point beginning corner.
