unpaid after expiration of grace period provided for above, then in any or all of such events, this agreement of lease shall henceforth terminate at the option of the Lessor and any unmature ed rent shall become immediately due at the option of the Lessor, and the Lessor may thereupon lawfully enter into and upon premises, or any part thereof, and repossess the same and eject the Lessee and those claiming under it and remove its effects by legal action, if necessary, without being deemed guilty of any manner of trespass and without prejudice to any other claim or remedies the Lessor may have or use for arrears of rent or breach of covenant .

- 6. The Lessor covenants and agrees that if the Lessee shall pay rent herein provided, and shall keep, observe and perform all of the covenants and agreements of this lease, by the said Lessee to be kept, observed and performed, the Lessee shall and may peaceably and quietly have, hold and enjoy the said premises for the term aforesaid.
- 7. It is further understood and agreed by and between the parties hereto that the covenants and agreements herein contained are binding upon the parties hereto as well as upon theirarespective administrators, executors, heirs, successors and assigns.
- 8. It is understood and agreed that the Lessee prior to entering upon the occupancy of said premises under this lease is to purchase from the Lessor the gasoline pumps now located on said premises at the established prevailing price for the same.
