designated representative, fails to approve or disapprove such design and location within 30 days after said plans and specifications have been submitted to it or, in any event, if no suit to enjoin the erection of such building or the making of such alterations has been commenced prior to the completion thereof, such approval will not be required and this Covenant will be deemed to have been fully complied with. Neither the members of such committee, nor its designated representative shall be entitled to any compensation for services performed pursuant to this Covenant. The powers and duties of such committee, and of its designated representative, shall cease on and after Jan. 1, 1967. Thereafter the approval described in this Covenant shall not be required unless, prior to said date and effective thereon, a written instrument shall be executed by the then record owners of a majority of the lots in this subdivision and duly recorded appointing a representative, or representatives, who shall thereafter exercise the same powers previously exercised by said committee.

- 3. No building shall be located neared to the front lot line or nearer to the side street line than the building setback lines shown on the recorded plat. In any event, no building shall be located on any residential building plot neared than 30 feet to the front lot line of lots 1-5 inclusive, 7-13 inclusive, 35-36 inclusive, 61-76 inclusive, 78-85 inclusive, 105-116 inclusive nor nearer than 35 feet to the front line on all other lots, nor nearer than 10 feet to any side street line. No building, except a detached garage or other outbuilding located 75 feet ormore from the front lot line, shall be located nearer than 5 feet to any side lot line.
- 4. No residential structure shall be erected or placed on any building plot, which plot has an area of less than 8000 square feet or a width of less than 70 feet at the front building setback line.
- 5. No noxious or offensive trade or activity shall be carried on upon any lot nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood.
- 6. No trailer, basement, tent, shack, garage, barn, or other outbuilding erected in the tract shall at any time be used as a residence temporarily or permanently, nor shall any structure of a temporary character be used as a residence.
- 7. No dwelling costing less than \$4500.00 shall be permitted on lots 30-36 inclusive, 39-46 inclusive, 55, 61-76 inclusive, and no dwelling costing less than \$6500.00 shall be permitted on lots numbers 1-5 inclusive, 7-16
