

BEGINNING at an iron pin on the West side of North Main Street at joint front corner of Lots Nos. 6 and 7 of Block "B" and running thence with the line of Lot No. 6 N. 89-55 W. 191.6 feet to an iron pin; thence along the rear line of Lots Nos. 17 and 18, in a Northerly direction 70 feet to an iron pin at joint rear corner of Lots Nos. 7 and 8; thence with the line of Lot No. 8 S. 89-55 E. 193.8 feet to an iron pin on the West side of North Main Street; thence with the West side of North Main Street, S. 2-05 W. 70 feet to the beginning corner.

This property is conveyed subject to the following restrictions and reservations:

- (1) No building shall be erected nearer than 50 feet to North Main St.
- (2) No dwelling shall be erected on said lot costing less than \$4000.00
- (3) This lot shall be used for residential purposes only, except this shall not apply to Section D on the plat above mentioned.
- (4) The property shall not be sold, rented or otherwise disposed of to persons other than of the Caucasian race.
- (5) No obnoxious or offensive trade shall be carried on on the property.
